Spud ed 17 1/2" hole 9:00 PM 3-24-54

On March 25, 1954 252' of new 13-3/8" casing was run in a 17 1/2" hole and cemented at 266', with 275 sx. reg. cement. Cement circulated to surface. After 30 hours WOC tested casing with 500 psi for 30 minutes before and after drilling plug and as there was no loss in pressure drilling operations were resumed.
