## FULL DETAILS OF PROPOSED PLAN OF WORK

FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS OF THE COMMISSION

The subject well was drilled to a total depth of 340 feet in red bed and 13 3/8" OD 48# GH-40 SS (New) Surface casing string was run and set at 282 feet with 250 sacks of cement on October 17th at 4:00 P. M. On October 19th, 4:00 P.M., 48 hours will have elapsed since setting surface casing and we plan to test casing shut off in the following manner:

Build up 1000# pressure and hold for 30 minutes, if test is OK, plug will be drilled; after which pressure will again be built up to 1000# pressure and held for 30 minutes, if this test, too is OK, drilling operations will be resumed.
