1. Inject 55 gals Cheplex (scale inhibitor) mixed with 500 gals of HCL (5%).
2. Clean out to total depth.
3. Run radioactive log from surface to total depth.
4. Install 4993' of 2" plastic coated injection tubing with packer set at 4712'. Change wellhead equipment for injection.


