FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS OF THE COMMISSION

At 4:30 PM, May 12, 1945, 48 hours will have elapsed since setting 4717 ft. of new 5½" OD 14# Smls. Casing and cementing with 400 sacks to be used for oil string. At this time casing shut-off will be tested as follows:

A pressure of 1000# will be built up and held for thirty minutes and if casing shut-off tests OK, cement plug will be drilled. A pressure of 1000# again will be built up and held for thirty minutes, and if this test, too, is OK, drilling operations will be resumed.
