FULL DETAILS OF PROPOSED PLAN OF WORK

FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS OF THE COMMISSION

Halliburton Drill Stem test was taken from 4727' to 4950'. The tool was open 2 hours. Recovered 330' of water cut mud and 841 feet of sulphur water. Another drill stem test was made from 4950' to 5100'. The tool was left open for 1 hour and 33 minutes. Well made 3300' of sulphur water and mud through 5/8" choke. The drill stem tests as shown above indicated the well could not be made into a producer and decision was made to plug and abandon the well. The proposed plan is as follows: Will place cement plug from 5100' to 4950' using 135 sacks of cement. Hole will be mudded to the bottom of the 7-5/8" casing which is set at 1978'. A 200' cement plug will be placed in the bottom of the 7-5/8" casing and the hole will be mudded to the bottom of the 10-3/4" casing set at 326'. A 100' cement plug will be placed in the bottom of the im 10-3/4" casing and the hole mudded up to 25° of the top of the hole. A 25' plug will be placed in the tep of the 10-3/4" casing and a bull plug placed in the top of the hole. As much as possible of the 7-5/8" casing will be recovered. Suitable marker will be placed in accordance with plugging regulations of the Commission.
