DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

The above well was plugged and abandoned in accordance with Form C-102 Approved 9/8/52, as follows:

25 sack cement plugs were spotted at the depth of 9700; 9150; 5450; 4887, with the interval between and above being filled with 9.4# mud.

Approximately 1500' of 8-5/8" casing was shot off and pulled and a 25 sack cement plug was placed to the surface. A 4" abandonment marker was installed and the location restored to its original contour to conform with New Mexico Oil Conservation Commission regulations.
