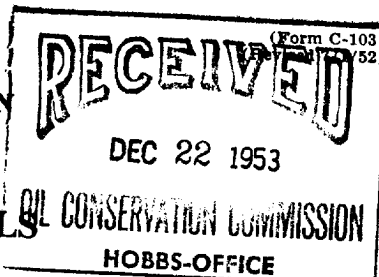

Started drilling 11" hole from 305' @ 2:15 P.M., 12/17/53 -
