DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

State "AJ" No. 1 was drilled to a total depth of 3370' in line. Ran 3356.39' (85½ jts) of 8-5/8" OD 24# and 32# 8R J-55 SS Csg. set at 3369' and cemented with 2198 sacks containing 4% gel and 400 sacks neat on bottom. Cement circulated. Plug down at 6:20 PM 5-14-53. Circulated out approximately 300 sacks. Cement was allowed to set 48 hours, 1000# pressure was applied with all valves closed. Test was satisfactory and drilling resumed.
