DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

State "AJ" #1 was drilled to a total depth of 335' in red bed. Ran 8 jts or 316.81' of 13 3/8" OD 48# 8R SS Casing set at 335' and cemented with 350 sacks regular neat cement. Circulated out 35 sacks. Plug down 11:45 A.M. 5-8-53. Cement was allowed to set 24 hours, 1000# pressure was applied with all valves closed with no drop in pressure. Test was satisfactory and drilling was resumed.
