A 11' hole was drilled from 300' to 4040'. 8-5/8", 32#, J-55, smis casing was cemented at 4040' using 974 sacks as follows: 624 Incor 12% gel, 200 sacks 1-1 Posmix 2% gel, and 150 neat cement. Cement did not circulate. The casing was pressure tested to 1200 psi for 30 minutes before drilling plug and cement tested to 800 psi for 30 minutes after drilling plug. Cement was allowed to set 36 hours before resuming operations.
