DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

On 9-16-52 at a T.D. of 6763' a caliper log was run and we decided to set 7" casing through the salt and red bed section to prevent washing out. We ran 5040' of 7" 23# smls. casing and cemented with 50 sax by Halliburton. After allowing the cement to set 48 hrs., we released the tension on the casing and discovered we did not have a cement job. We then ran the casing on to total depth of 6763' and cemented with 150 sax by Halliburton on 9-24-52. After allowing the cement to set 48 hrs., casing was tested and drilling resumed.
