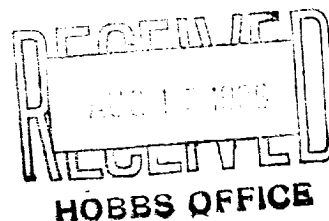
FULL DETAILS OF PROPOSED PLAN OF WORK
