DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

On January 29, 1954 3277' of 9-5/8" was run in a 12 1/2" hole and cemented at 3289' in two stages with the D. V. tool set at 2049'.

1st Stage - 150 sx. neat

2nd Stage - 150 sx. neat

After 30 hours W. O. C. tested casing above DV tool w/1200 psi for 90 minutes, before drilling plug with 1100 psi for 30 minutes, after drilling plug with 900 psi for 30 minutes, and as there was no loss in pressure drilling operations were resumed.
