FULL DETAILS OF PROPOSED PLAN OF WORK

FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS OF THE COMMISSION

This well was drilled to a total depth of 5302' in line 1200' of salt water was encountered at 4745'. 1625' of salt water was encountered at 5208'. A hole full of sulphur water was encountered at 5300'.

It is proposed to plug and abandon this well as follows:

A cement plug will be set from 5302' the total depth back to 4700'. The hole will then be filled with 12 lb. mud from 4700' to 3200' and a cement bridge set from 3200' to 3150'. The hole will then be filled with 12 lb. mud from 3150' to the bottom of the 8-5/8" casing cemented at 2020'. An attempt will be made to pull the 8-5/8" casing and a cement bridge will be set at the point the pipe is shot off. The hole will be filled with 22 lb. mud from this point back to the base of the 13" surface pipe and a cement bridge set in the bottom of the 13" casing. The hole will then be filled with 12 lb. mud back to a depth of 20' and a cement plug set from 20' back to the surface. The cellar and pits will be filled in and a marker erected according to State regulations.
