12620' - Total Depth - Line. Run Temperature Survey - top of cement on outside of 5-1/2" casing at 8864', ratio of actual to calculated fill 98.8%. Checked top of cement at 12491' and tested 5-1/2" casing & connections with 1200# for 1/2 hour - no pressure drop. Drilled cement to 12600' and tested casing & connections with 1200# for 1/2 hour - no pressure drop. Continued with completion operations.
