4790' - Total Depth - Lime - Ram Temperature Survey - Top of cement behind 8-5/8" O.D. Casing at 2500', actual fill 2290', calculated fill 6370', ratio of actual to calculated fill 36%. Checked top of cement at 4700'. Tested casing & connections with 1250# for 1/2 hour - no pressure drop. Drilled cement from 4700' to 4790' & tested casing & connections with 1250# for 1/2 hour - no pressure drop. Started drilling formation & 7-7/8" hole at 3:00 P.M., 5-9-50.
