4800' - Total Depth - Line. Ran Temperature Survey - Top of cement on outside of 8-5/8" casing at 2417', ratio of actual to calculated fill 47.3%. Checked top of cement at 4722'. Tested casing & connections with 800# for 1/2 hour - no pressure drop. Drilled cement from 4722' to 4800' & tested casing & connections with 800# for 1/2 hour - no pressure drop. Started drilling formation and 7-3/8" hole at 9:25 A.M., 2-20-51.
