Ran 11 Jts (348') 13-3/8" OD 48# Gr H-40 SS casing. Set and cemented at 365' with 425 sacks Regular Neat cement. Plug at 350'. Maximum pressure 200#. Circulated estimated 25 sacks cement. Job complete by Howco 9:30AM 12-24-54.

After waiting over 24 hours, tested 13-3/8" casing with 1000# for 30 minutes. There was no drop in pressure. Drilled cement plug from 350' to 365'. Tested below casing shoe with 400# for 30 minutes. No drop in pressure.
