Plugging Procedure:

1. Pulled rods and tubing. Set cast iron bridge plug in 5 1/2" casing at 12,090'. Pumped 4 sx (35') of cement on top of plug.
2. Ran tubing and circulated hole with 10# salt gel mud. Pulled tubing.
3. Shot and pulled 5 1/2" casing from 5420'.
4. Ran tubing and set cement plugs as following:
 - a. 100' (35 sks) in and out stub of 5 1/2" casing from 5466' to 5366'. Tagged plug @ 5340'.
 - b. 200' (70 sks) from 5100' back to 4874'.
 - c. 100' (40 sks) at top of salt at 2460' back to 2360'.
 - d. 10 sks in top of 9 5/8" casing and set a 4' permanent marker.
5. Well P&A, 11-11-80.
