



Dear Sir:

This is to advise Phillips Petroleum Company's M. E. Hale No. 4, located 660' from South line and 1980' from West line of Section 35, Township 17-S, Range 34-E, Vacuum Field, Lea County, New Mexico, was drilled to a total depth of 4678' under date of July 8, 1939. This well was tubed with 2" USX tubing to 4675'.

After swabbing out the fresh water used to displace lime dust drilling solution, the well started flowing. July 11th, on 24-hour test, the well flowed an average of 7 barrels hourly by running swab approximately three times per hour to 4,000' to keep well flowing. Gas was not measured.

We wish to ask for top allowable of the Vacuum Field for this well, effective July 16, 1939.

We intend to acidize this well today with 1,000 gallons of Dowell XME-2. After securing test with gas reading after the acid treatment, we will submit your regular completion form.


