FULL DETAILS OF PROPOSED PLAN OF WORK

(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

- 1. Pull tubing, run Caliper Survey of open hole.
- 2. Run 3" X-line frac tubing w/Lynes formation packer set at approximately hh25'.
- 3. Treat below packer w/15,000 gallons lease oil containing 1# sand/gallon & sufficient FLA to maintain spurt loss less then 10 cc & 30-minute fluid loss less than 20 cc.
- 4. Leave shut in one hour. Bleed off pressure, pull 3" tubing & packer, plug back open hole w/sand to hh25'. Rerun 3" tubing w/packer set immediately below casing shoe if packer seat available. If no seat available, set packer in casing.
- 5. Treat w/15,000 gallons lease oil containing 1# sand/gallon.
- 6. Shut in overnight, bleed off pressure and pull 3" tubing.
- 7. Clean out sand to TD.
- 8. Run tubing, swab test, place on pump.
- 9. Recover load and place on production.
