- CO to 6258' (PBDT). Set RBP 5910' and spot 10' sand on top.
- Run CBL/CCL/VDL/GR logs from 5900' to surface to determine TOC.
- Perf 4 1/2" csg @ TOC. Set cmt retainer 150' above perfs.
- Pressure up backside to 500 psi. Pump  $\pm$  1500 sx cement. Circ to surface. Reverse out excess.
- WOC 24 hrs.
- DO cmt and pressure test squeeze to 500 psi. Reverse out sand.
- CO to 5900'. Lower BP to 6100'. Spot 200 gals 15% HCl-NEA acid across zone to be perf'd.
- Perf Glorieta 6012' - 6045' (32 holes) and acidize w/3200 gals 15% NEA acid.
- Return well to production.
