Work began 5/13/85. Treated perfs 9657-9718 with 4,000 gallons 15% NEFE acid, flushed with 8,000 gallons KCL water. Swab load. Set Packer at 9600 & perf 9549 to 9537. Treat with 2,000 gallons 15% NEFE acid, flush with 420 gallons KCl water. Ran rods & pump. Pump load, well kicked off flowing. 5/21/85 flowed 297 bbls oil, no water, 282 MCF gas, 24 hours thru 1/2" choke, FTP 70#.
