We propose to do the following work on subject well:

1. Pull the pump equipment.
2. Perforate the 2 7/8" O. D. Casing with 1 jet shot at 9627', 9630', 9637', 9640', 9646', 9650', 9656', 9659', 9664', 9732', and 9734'.
3. Set bridge plug at 9800'.
4. Acidize with 3000 gallons 15% NE acid in two stages with ball sealers between stages.
5. Swab well, recover load, Test, and place well on production. (If well does not flow top allowable, pull bridge plug)
