Drilled 7-7/8" hole to 10203' T.D. Schlumberger ran GR-Sonic & Dual Induction Laterolog. Ran 291 jts of 5-1/2" combination casing w/float collar & float shoe=10189.88'. Set at 10202'. Halco cemented w/152 sx Incor neat + 1/2 of 1% CFR2. Plug down at 1:45 AM 12/19/63. By temperature survey, top of cement at 9200'. Tested 5-1/2" casing to 1600# for 30 min. Held OK & job complete at 5:30 AM 12/20/63 after 27 hrs WOC. Perforated Bone Springs 10081-10108' & 10118-144' w/2 JSF. Treated perms w/1000 gal. mud acid. Swabbed & flowed back all of load plus first new oil. Treated w/5000 gal. 15% ISTNE HCl acid. Ran completion assembly consisting of 335 jts 2-1/2" EUE 8R 6.5# N-80 tubing and TIW-JSAC packer=10011.51'. Bottomed at 10021.97'.
