TEXACO Inc. proposes to do the following work on subject well:

1. Orient and perforate Wolfcamp down 2-3/8" casing w/2 JSPI @ 9601', 03', 21', 24', 9701', 03', 38', 40', 41', 57', 58', 9851', 60', 9895', 96', 9981', 10,036', 46' and 49'.
2. Acidize w/6000 gals. retarded 15% acid in stages as follows: Run base temp log. Pump 100 Bbls. treated water pad and log. Pump 1000 gals. acid followed by sufficient Benzoic Acid flakes to block existing pay. Overflush w/50 Bbls. treated water and log. Pump remaining acid in 1000 gals. stages logging and diverting as necessary. Log after final stage.
3. Swab until flowing and place on production.
