Cement did not circulate so ran 2 joints of 1" tubing beside casing and cemented from surface to 50' with 50 sacks Incor 4%. Cement circulated. POB 7:10 A.M. 7-29-64. WOC 18 hours. Tested casing with 1000# for 30 minutes-no drop in pressure. Drilling.
