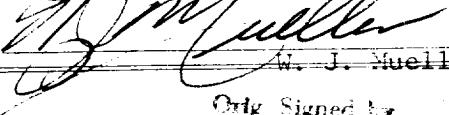
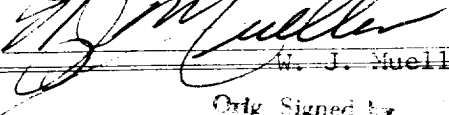

This well was originally drilled at an orthodox location to test the Vacuum Wolfcamp Glorieta and Abo Reef formations. These formations have now been abandoned and the well bore was completed in February, 1978, in the Vacuum Grayburg/San Andres Pool for bottom hole pressure monitoring. Present PBDT is 4800' with Grayburg/San Andres zone perforated 4610-24' and 4632-54'.
