1. Ran tubing, spotted 300 gallons MCA with Fe additive on bottom, pulled tubing
2. Ran GR-Correlation log 6265' - 2700'.
3. Perforated 6103', 6105', 6108', 6114', 6115', 6117', 6125', 6131', 6132', 6133', 6136', 6138', 6140', 6147', 6148' with 1 3/8" Js (Total 15 holes).
4. Ran tubing with Baker packer open ended and set at 5800'.
5. Treated with 300 gallons MCA + 1500 gallons 15% NEA in 15-100 gallon stages using ball sealers.
6. Raised tubing and hung 189 jts (5969') 2", EUE, 8rd tubing open ended at 5997', Baker 2" x 4 1/2" Model "R" Double Grip packer 5982' - 5990', Seating Nipple at 5981'.
7. Recovered load.
8. On OPT flowed 325 BOPD + 86 BWPD (based on 230 BO + 61 BW in 17 hours) thru 22/64" choke. FTP 200-300 psi. Gr. 38.6 deg. API.
