Well spudded July 8, 1964. Set 51 joints (1600') of new 8-5/8" OD 24# 8-R SS J-55 R-2 RTG casing set at 1610' and cemented with 1,000 sacks of cement by the pump and plug process. Cement circulated to surface. Plug down at 7:45 A.M., July 10, 1964, W.O.C. 24 hours. Pressured up to 1000# for 30 minutes and casing tested OK. Drilled out cement plug and pressured up to 1000# for 30 minutes and casing shut off tested OK.


