Cement will be circulated to approximately 2800' on the 4-1/2" OD casing. The 4-1/2" OD casing will be set at approximately 6300'. The 4-1/2" OD casing will be perforated and treated with approximately 900 gallons of Acid.

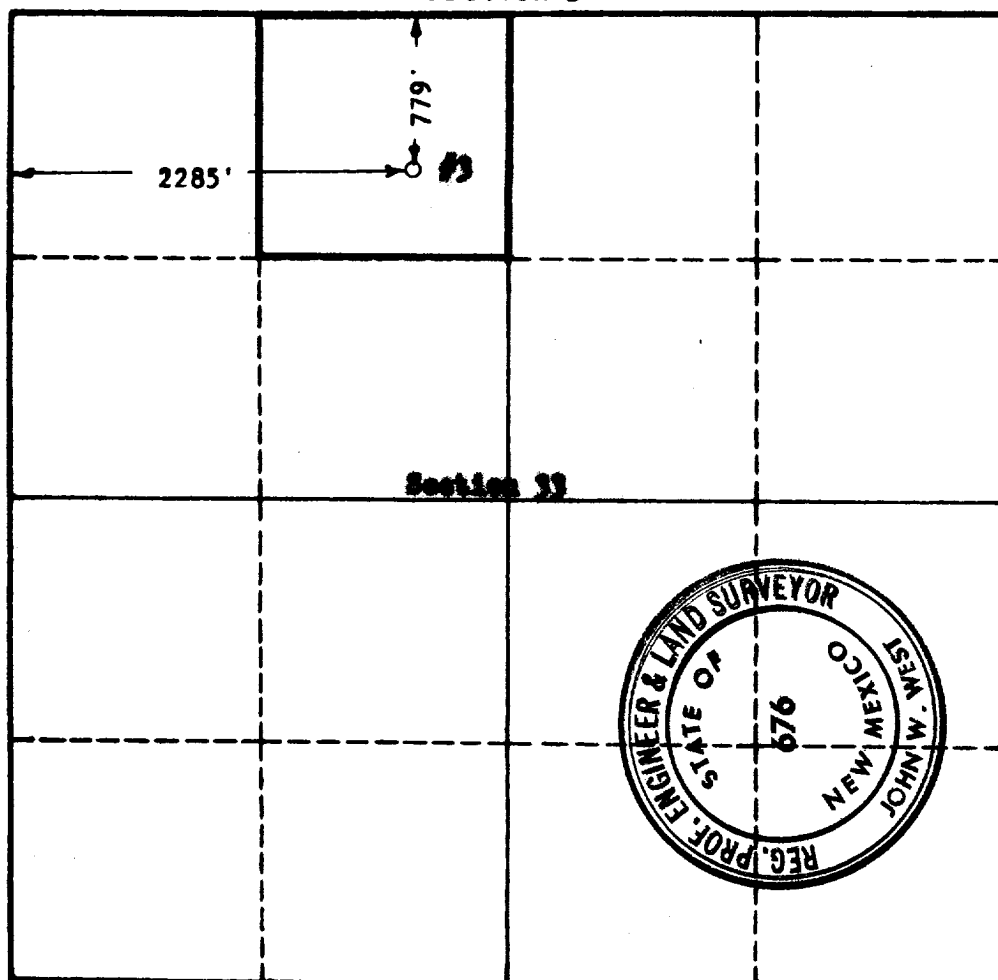
