3. Cement 1st stage w/25 sks Incore Pos 2% gel, 271 sx Incore Pos 6% gel w/12 1/2# Gilsomite per sx plus 100 sx Incor Pos 2% gel. Open DV tool, circ 4 hrs, didnot circ any cmt.
4. Cmt 2nd stage w/25 sx Incore Pos 2% gel plus 271 sx Incore Pos 12% gel w/12 1/2# Gilsomite per sx, tailed in @/25 sx Incore Pos. 2% gel. Circ 250 sx to pit.
5. WOC 48 hrs. Drill DV tool @ 5889', drill cmt 8224 to 8382, test csg to 2000# O.K.
6. Perf 2 holes per ft 8304-10, 8323-50. Ran 267 jts 2 3/8" tbg to tbg point 8374'. Acidize perfs w/500 gal HDA and 3000 gal XM38. Nipple up tree and put on production.
