\* 400 sacks Class "C" 4% gel, followed by 200 sacks Class "C" Neat. Neat to contain accelerator.

\*\* Externally clean casing & install centralizers over prospective zones. Cement with 450 sacks Class "C" 8% gel, followed by 300 sacks Class "C" 4% gel. Displace plug with acetic acid.

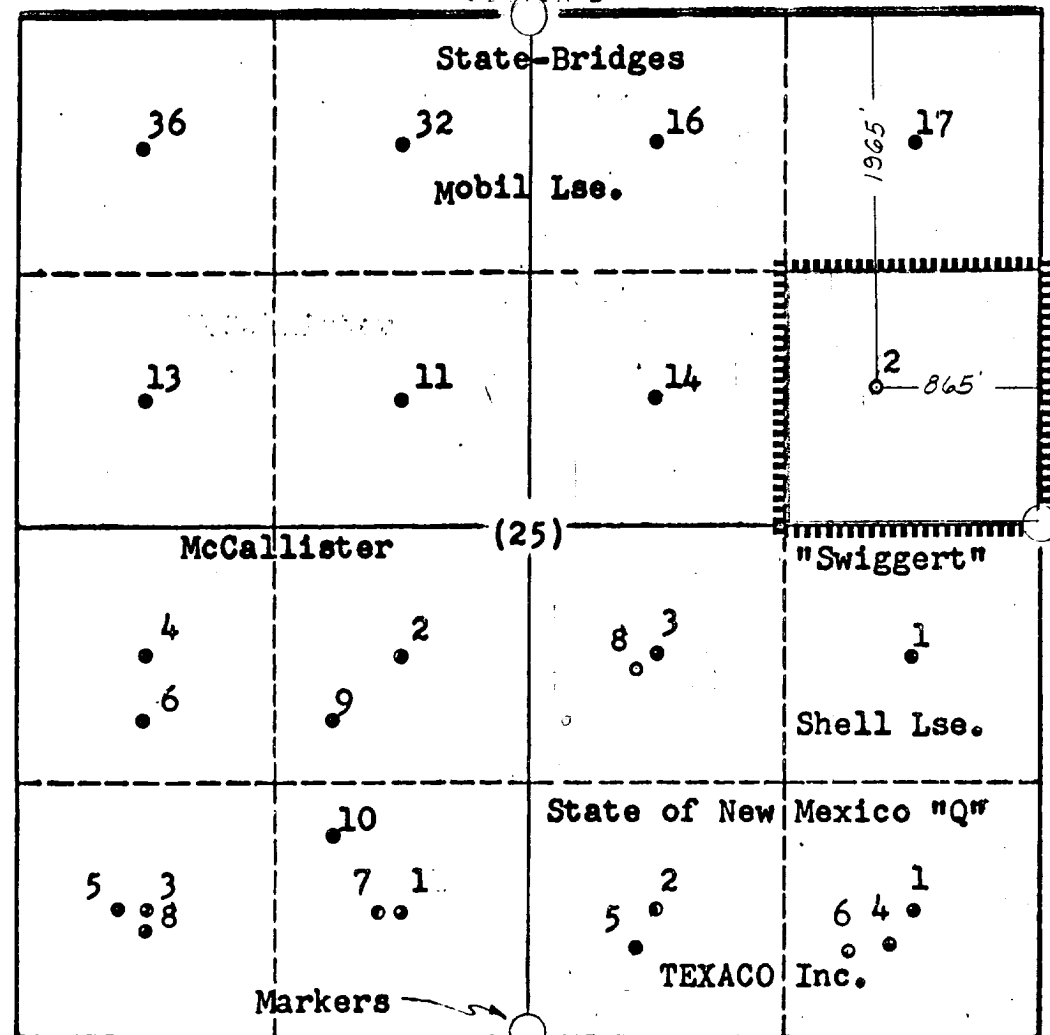
