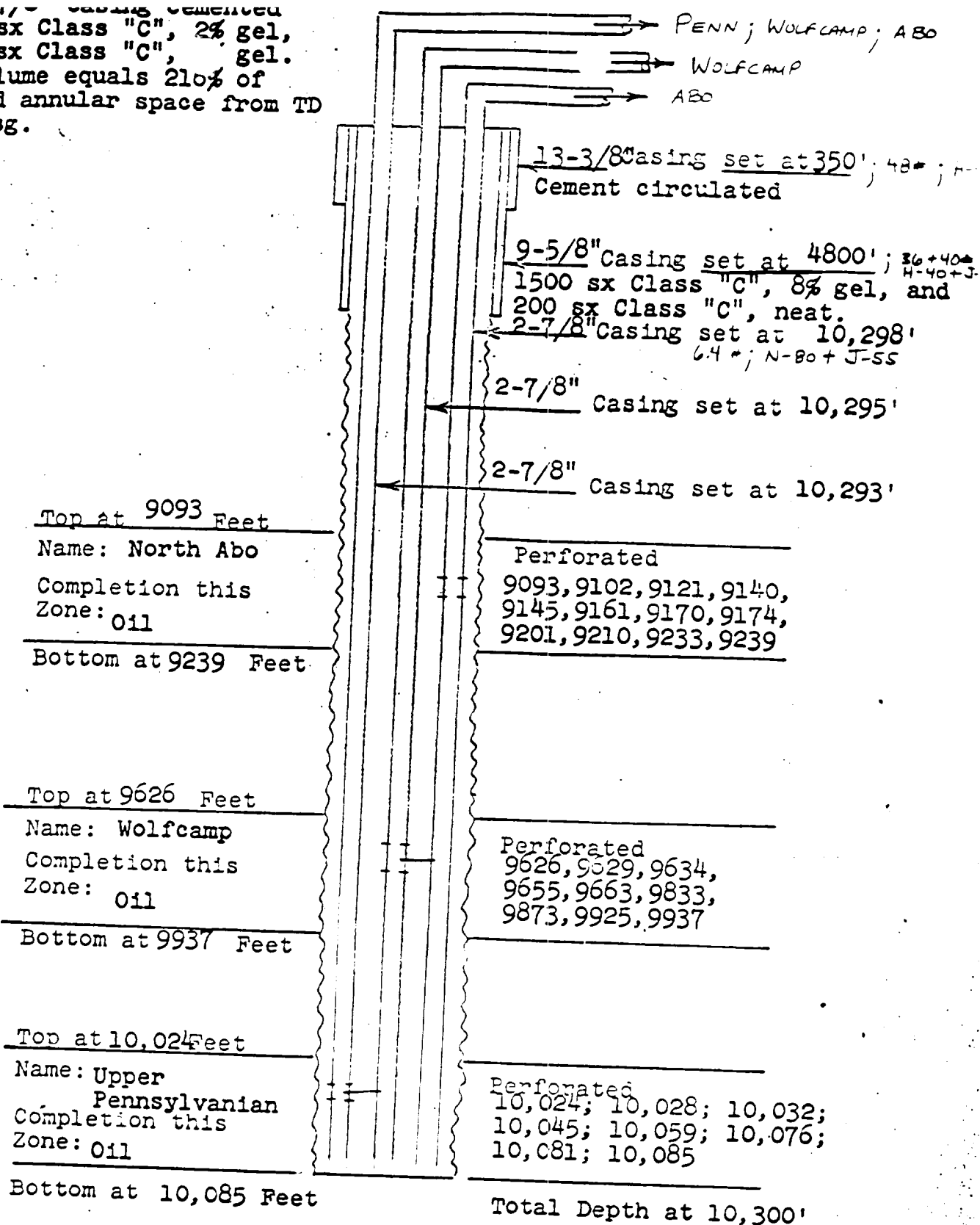

Plug and Abandon**

Procedure:

1. MIRU Workover Rig. Blow down all three 2 7/8" production strings.
2. Penn String: Rig up pump truck and squeeze perforations. Fill Tubing to surface with cement.
3. Wolfcamp String: Rig up pump truck and squeeze perforations. Fill tubing to surface with cement.
4. Abo String : Rig up pump truck and squeeze perforations. Fill tubing to surface with cement.
5. Dig out and cut off well head 3' below ground level. Weld ½" steel Plate on top of casing.
6. RDMO. Clean location.
