We propose the following remedial work which will be commenced on or about February 15, 1973.

1. Set cast iron bridge plug at 10,200' with 30' cement cap.
2. Perforate 9612' - 9616' with 8 holes.
3. Run tubing and packer
4. Treat with 1000 gallons 15% HF acid.
5. Run pump and rods and return to production.
