We mistakenly filed a Subsequent Report without first filing a Notice of Intent to temporarily abandon this well. We planned to TA this well by setting an Elder cement retainer at 4487.81'. The retainer was set and the hole was circulated with treated 2% KCl water and pressure tested to 500 psi for 30 minutes. This work was performed on 3/30/93 and the test was witnessed by an OCD representative. A Subsequent Report with a copy of the pressure chart was mailed to your office on 3/31/93.
