Devon respectfully requests that additional time be granted, beyond the original thirty(30) day extension, to permanently plug and abandon the subject well due to the following time constraints:

1. Devon has not yet received full partner approval for the expense AFE's.
2. +/-30 days before plugging contractor can commence with plugging operations.
3. Devon has recently entered into an agreement with a company to purchase various properties currently owned by Devon. The purchaser has subsequently expressed an interest in examining those wellbores currently scheduled for abandonment for any possible behind pipe potential/exploiation and would require additional time to complete those reviews.

It is therefore requested that an additional sixty(60) days be allotted before plugging operations commence.
