Devon has recently entered into an agreement with a company to purchase various properties currently owned by Devon. The purchaser has subsequently expressed an interest in examining those wellbores currently scheduled for abandonment for any possible behind pipe potential/exploiation and would require additional time to complete those reviews.

It is therefore requested that additional time be allotted before plugging operations commence.
