Incor Neat, cement containing .07% CFR-2, PD @ 11:30 p.m. 6-20-67, plug did not latch in w/12 bbls over displacement, reversed out approx. 100 bbls. of cement on top of liner approx 300 sks., pulled DP and setting tool, ran 8-3/4 bit, found top of liner 10' low 4813, no cement on top of liner, ran 6-1/4 bit and csg. scraper on 4-4-1/4 DC's and 2-3/8 tbg to 10,329, top of latch collar, pulled tbg, DC's, scraper and bit, Welex ran cement bond log from 4806 to 10,307, log indicates free pipe 10,190-10,307 - indicates liner in cement to 4806.
