Propose to run a pump-in tracer survey to determine source of water as follows:
Pull rods, pump, and tubing. Run 1 joint 2-3/8" tailpipe, packer, and 2-3/8" tubing to surface. Land tailpipe at 3250' and set packer. Run pump-in tracer survey. If survey does not indicate an channel or broken down perfs, a supplemental brief will follow. If survey indicates a channel behind pipe or previously squeezed perfs broken down, continue as follows:
Pull tubing and packer. Set a cement retainer at apx. 3300'. Squeeze with 200 sacks of class C cement and additives. Reverse out excess cement. Clean out to 3360' and perforate 3346'-3350' with 4 DPJSPF. Run 3 joints 2-3/8" tailpipe, packer, and 2-3/8" tubing to surface. Land tailpipe at 3250' and set the packer. Swab test to evaluate production. Pending results of swab test acidize with 250 gal 15% NEFE HCL and additives. Swab test and evaluate production. Pull tubing and packer. Run seating nipple, tubing, rods, and pump per previous design. Return well to production.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
