REVISED PROCEDURES

Devon Proposes To Permanently Plug And Abandon As Follows:

1. Set CIBP at 3,800' and cap CIBP with 35' of cement.
2. Spot balanced cement plug 3,250'- 3,350' (base of salt at 3,300'). WOC. Tag plug.
3. Cut off 4 1/2" casing at 1,900'.
4. Circulate wellbore full of 9.5 ppg mud.
5. Spot balanced cement plug 1,800'- 1,950' (top of salt at 1,900'). WOC. Tag plug.
6. Spot cement plug 275'- 375' (surface casing shoe at 326'). WOC. Tag plug.
7. Spot cement plug 0'- 50'.
8. Cut off 8 5/8" casing 3' below ground level and install dry hole marker.
9. Restore location.

Note: Cement to be Class "C" at 14.8ppg with a yield of 1.32 cu ft/sx.
