Gentlemen:

Reference is made to the recent application to deepen the subject well from 9744 to 14,700 feet to test the Devonian. Extensive testing of the Pennsylvanian formation is also planned. Geological data would indicate a possibility of commercial gas production in the Atoka or Morrow formations.

The subject well is located 2086 feet from the North line and 554 feet from the West line of Section 36, and it is thus an unorthodox location for a 320-acre proration unit as required for gas production from this depth.

Therefore application is hereby made on behalf of C. W. Trainer for administrative approval of an unorthodox well location for a 320-acre proration unit to consist of the North one-half of Section 36.

Attached is a plat of the area showing the offset operators and the location of offset production. All such operators have been furnished a copy of this application by certified mail as reflected by attachments "A" and "B".
