Ran 2-3/8" 4.7# EUE plastic lined tubing and plastic lined Baker Model "R" packer to 8838'. Filled 2-3/8"--5-1/2" annulus with inert fluid. Pressure gages on both tubing and annulus. Started injecting formation water on vacuum. Pop-off valve for 1783 psi will be installed when it is necessary to inject water under pressure.
