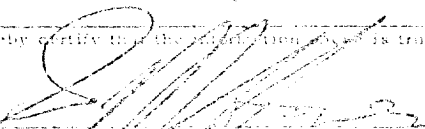

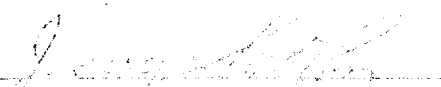

- Plugging Procedure:
- 1.) Trip out of hole with tbg & pkr.
 - 2.) Set an SV-EZ drill cement retainer @ 10,150'
 - 3.) Trip in hole with stinger and squeeze the perfs from 10,806 to 10,834 (8 holes) with 75 sacks Class II cement containing .2% HLX 242; leave 1 bbl cement on top of plug.
 - 4.) Circulate the hole with 9#/gal mud laden fluid. Trip out of hole.
 - 5.) Run a freepoint survey and cut the 5" 15# casing. Laydown the casing.
 - 6.) Trip in hole and spot 100 sacks Class II cement across the cut in the casing.
 - 7.) Pull the tubing to 4985' and spot 50 sacks Class II cement across the bottom of the 9-5/8" casing.
 - 8.) Pull the tubing to 2000' and spot 50 sacks Class II cement across the top of the salt section.
