The above well was drilled and completed March 10, 1981 as an oil producer. On August 30, 1982 it was converted to a water injection well. Workover procedures are as follows:

8-30-82: Ralph Johnson pld & LD rods & tbgs. WIH w/134 jts of 2-7/8" J-55 plastic coated tbgs w/5-1/2" Brown-Huskey M-1 pkr w/left hand on/off tool. Set pkr @ 4317. Hooked up wellhead. RD WSU. Started injecting dwn 2-7/8" tbgs thru 5-1/2" csg perms from 4394' to 4564' at rate of 1440 BWPD w/vacuum pressure.
