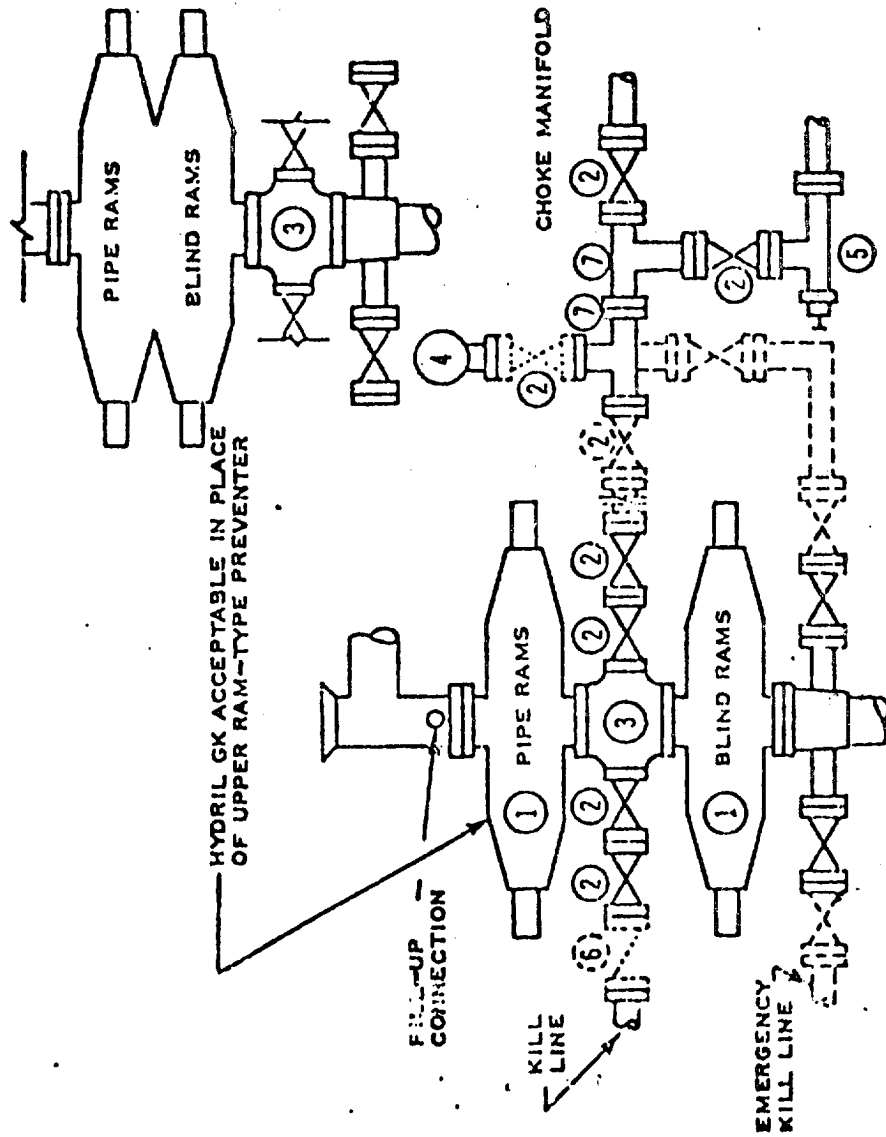


DOUBLE PREVENTER OPTION

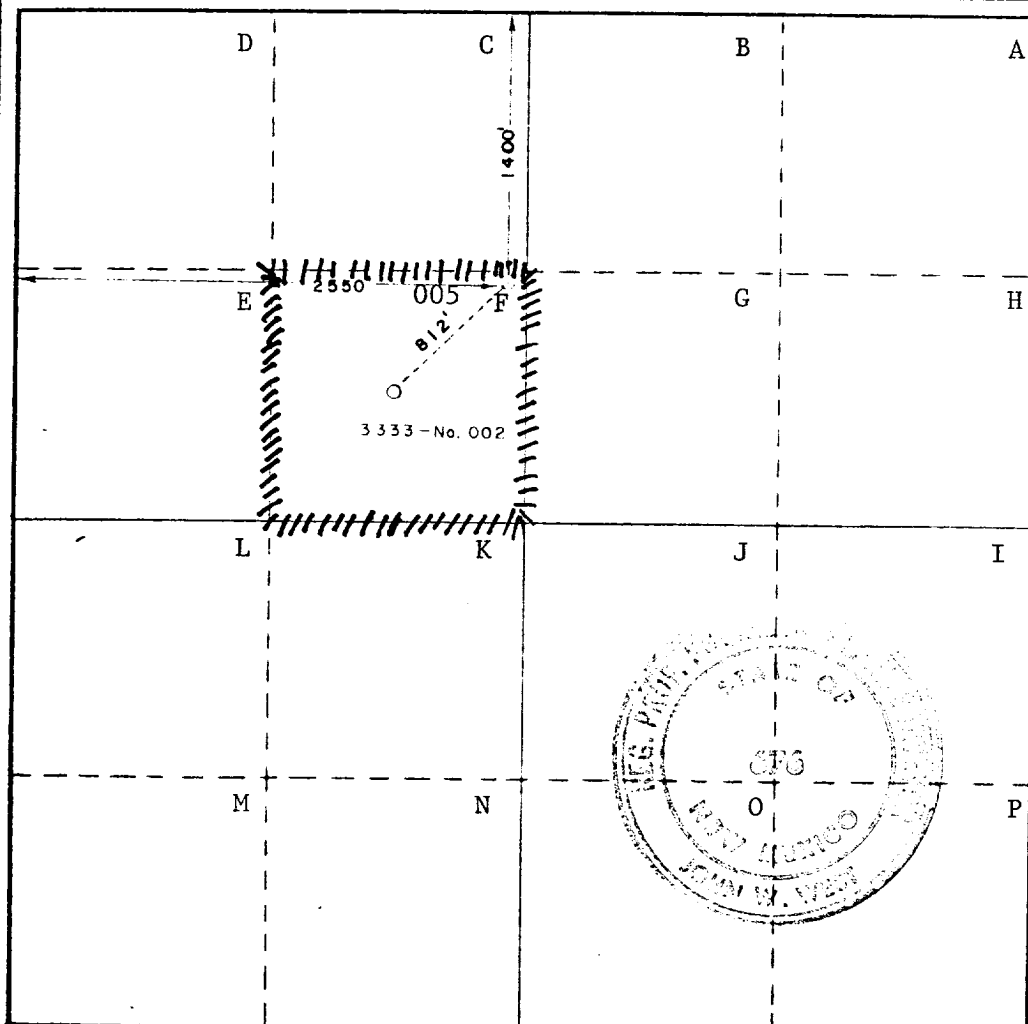
