- 10/ 2/84 Moved in well service unit and rigged up. Pulled rods, pump, and tubing. Rigged up Schlumberger. Set CIBP at 3425'± and cased with 2sx, 22'± cement. Perforated with casing gun: 3266-3275', 2SPF, 15 holes; 3279-3286', 2SPF, 15 holes; 3066-3068', 2SPF, 3 holes; 3057-3062', 2SPF, 11 holes; 3042-3048', 2SPF, 13 holes; total of 57 holes. Picked up RBP, RTTS, and tubing. Set RBP at 3320'±. Backed off RBP. Pulled RTTS back to 3250'± (collar at 3259'). Swabbed well down to remove as much fluid as possible. Proceeded with nitrogen and acid treatment per Halliburton procedure (5000 gal 7 1/2% MCA with 1000 SCF nitrogen/bbl). Maximum Pressure: 3500 psi, Rate: 3.2, no balls. Shut in Pressures: ISIP: 2400 psi, 5 min: 2300 psi, 10 min: 2200 psi, 15 min: 2100 psi, 20 min: 2100 psi. 126 BLWTR. Flowed back 26 BLW on 10/64 choke for remainder of day. 100 BLWTR. Shut down.
- 10/ 3/84 CP: 1800 psi. Opened well on 12/64 choke @ 7:00 AM. Flowed approximately 1 1/2 hours. Recovered 19 BLW. Well nearly dead, flowing by weak heads. Rigged up swab. First run recovered 4 BLW, CP increased to 1250 psi. Flowed and swabbed remainder of day. 81 BLWTR. Shut down.
- 10/ 4/84 TP: 180 psi, CP: 300 psi. Opened well, flowed and died. Swabbed every 30 min with fluid level 1600' from surface. Recovered 15 BLW. 66 BLWTR. Shut down.
