8/ 7/84 TP: 0 psi, CP: 60 psi, FL: 2500' from surface. Pulled tubing and ran sand pump. Sand top is at 4140'±. Recovered 35' of sand. Re-ran 128 jnts tubing to bottom. Swabbed 3 hrs and recovered 25 BLW. Show of gas, no show of oil. At 6:00 PM recovered 200 BLW. Have 383 BLWTR. Shut down.

8/ 8/84 TF: 150 psi, CP: 225 psi, FL: 2000' from surface. Swabbed dry in 6 hours. At 5:30 PM, no fluid entry. Small amount of gas after each run. Swabbed a total of 38 BLW. No show of oil. Recovered 238 BLW to date, 345 BLWTR.

8/ 9/84 TP: 270 psi, CP: 400 psi, FL: 2000' from surface. Swabbed 10 BLW in 2 1/2 hrs. Fluid level at 2900'. Good show of gas after each swab run. No show of oil. Fluid recovery to date is 248 bbls. 335 BLWTR. Shut down at 10:30 AM due to rain.

8/10/84 TP: 400 psi, CP: 780 psi, FL: 2200' from surface. Swabbed 13 bbls and swabbed dry. Total load recovered 261 bbls, 322 BLWTR. Shut down for weekend.

8/13/84 Monday: 60 hr shut in. TF: 600 psi, CP: 1040 psi. Well flowed approximately 9 bbls of water when first opened. FL: 2800' from surface. Will consider looking at next zone (Seven Rivers & Yates).

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
