Response to Notice of Incidents of Noncompliance #AJM-083-99

The Stivason Fed #1 has been approved by the New Mexico Oil Conservation Division for use as a salt water disposal well (Administrative Order No. SWD-407). Disposal will be in the Queen formation from 4866' to 4744'. Maximum injection rate is projected at 400 BSW per day.

We are presently in negotiations with Scurlock Permian Corporation to obtain a market for sufficient amounts of salt water to proceed with the installation. We anticipate that this may require one to two years to achieve.
