1. POOH w/ tbg and pkr. RIH w/ perforating gun and add perfs to 10,618' - 23'.
2. RIH w/ tbg and pkr. Acidize perfs 10,602' - 23' w/ 1,500 gallons 15% HCl NEFE acid.
3. Swab test 10,602' - 23' for FER and oil cut. Complete this zone if FER and oil cuts are acceptable.
4. Otherwise, POOH w/ tbg and pkr. Retrieve pkr from 11,000'.
5. Set CIBP @ 11,000' and cap w/ cmt.
6. Set CIBP @ 10,550' and cap w/ cmt.
7. Perforate 9,610' - 50' w/ 4" csg guns. Acidize 9,610' - 50' w/ 2,500 gallons 15% HCl NEFE acid.
8. Swab test 9,610' - 50' for FER and oil cut. Fracture stimulate zone if FER and oil cuts are acceptable.
9. Set RBP above 9,610' - 50'. Perforate zones from 9,100' to 9,326' with limited number of perfs to allow limited entry fracture stimulation.
10. Acidize 9,100' to 9,326' w/ 2,500 gallons 15% HCL NEFE acid.
11. Fracture stimulate 9,100' to 9,326' using limited entry technique.
12. POOH w/ RBP and pkr.
13. RIH w/ production equipment, set pumping unit, place well on production.
